Secretary Toulouse Oliver:

As reported to me by Robert Wagner, resident of Torrance County, I am bringing to your attention an issue concerning the Torrance County Clerk, Ms Yvonne Otero.

As per Section 10-1-10 NMSA 1978, It shall hereafter be unlawful for any person elected or appointed to any public office or position under the laws of this state or by virtue of any ordinance of any municipality thereof, to employ as clerk, deputy or assistant, in such office or position, whose compensation is to be paid out of public funds, any persons related by consanguinity or affinity within the third degree to the person giving such employment, unless such employment shall first be approved by the officer, board, council or commission, whose duty it is to approve the bond of the person giving such employment; provided, that this act [10-1-10, 10-1-11 NMSA 1978] shall not apply where the compensation of such clerk, deputy or assistant shall be at the rate of \$600 or less a year, nor shall it apply to persons employed as teachers in the public schools.

Clerk Otero's mother, Mary Theresa Otero, was appointed to the primary Election Board as a Presiding Judge. There is no evidence that this appointment was ever confirmed by the County Commission. While Mary Theresa Otero's concurrent appointment to the Board of Registration was approved by the County Commission, Mz Otero stated at that time that the Board or Registration position would be uncompensated.

An inspection of county payroll records show Mary Theresa Otero has been compensated to the sum of \$4102.40 thus far in the calendar year 2022.

- 1. Examine and validate these findings;
- 2. Refer this matter to the appropriate agencies for criminal investigation, if appropriate
